1ST telephone conference for DCNR grant, next conference will be held sometime in December to review the contract. Funds will be available after January 1st, 2021. Contract will state what funds should be used for. Changes can be made to contract by amendments. Borough already expressed to the DCNR Grant Project Manager that a change is wanted to the project. Vivian Amspacher inquired what exactly was being changed in the project and how much more money it will cost to complete. Jamie Moore explained that the Grant Committee would like to change the surface of the pump track from dirt to concrete to keep dirt bikes from going onto track and ruining it. It will not cost more than what is already budgeted since we are not allowed to go over the amount. If change cannot be done within price limit, then the pump track will just get removed from project.

Vivian Amspacher asked how much the Borough has into this, the grant requires the applicants to be able to match the \$250,000.00 grant to show funds are available. Also incurred so far were the grant writer fees which they will be reimbursed through other grants as well (minus 17%). Developer fees will be paid by grants (one grant already received was the \$20,000.00 which we can use to pay for the Developer fees.
