## ORDINANCE NO. 2022 - 08

### AN ORDINANCE AMENDING CHAPTER 51, SEWERS AND SEWAGE DISPOSAL, OF THE CODE OF ORDINANCES OF THE BOROUGH OF NORTH YORK, BY AMENDING THE BILLING DATE AND DATE OF PAYMENT

The Borough Council of North York Borough, York County, Pennsylvania, enacts and ordains as follows:

**Section 1.** Chapter 51, Section 51.02 of the Code of Ordinances of the Borough of North York is hereby amended and shall read as follows:

The above charges shall commence on the date the connection is made to the sewer system. All bills shall be rendered in calendar quarters and shall be subject to a 10% penalty if not paid within 30 days of the date of the invoice. Any owner of property connected or disconnected during any calendar quarter shall pay a pro rata rental and charge for the portion of the quarter during which said property is served.

**Section 2.** Severability.

It is hereby declared to be the legislative intent that if a court of competent jurisdiction declares any provisions of this Ordinance to be invalid, the effect of such decision shall be limited to those provisions which are expressly stated in the decision to be invalid. In such case, all provisions of this Ordinance that were not declared invalid shall continue to be separately and fully effective. Borough Council hereby declares that it would have passed all other parts of this Ordinance, without including any part declared invalid, if it had advance knowledge that such part would be declared invalid. If the entire Ordinance should be declared invalid, then the previous Sewers and Sewage Disposal Ordinance that was in effect immediately prior to the enactment of this Ordinance shall automatically be re-instated as the Ordinance for North York Borough.

**Section 3.** Procedural Defects in Enactment.

Allegations that this Ordinance or any amendment was enacted in a procedurally defective manner shall be appealed as provided in Pennsylvania law.

**Section 4.** Repealer.

Any provisions of the previous Chapter 51, entitled "Sewers and Sewage Disposal" that are inconsistent or incompatible with this Ordinance are hereby repealed and all other Borough ordinances or parts thereof that are inconsistent or incompatible herewith are repealed to the extent of such inconsistency or incompatibility. This Repealer clause shall only repeal Borough


Ordinances or parts thereof that were adopted prior to this Ordinance and that are clearly in direct conflict with this Ordinance.

**Section 5.** Enactment.

This Ordinance shall become effective on January 1, 2023.


