**A RESOLUTION OF NORTH YORK BOROUGH PROVIDING FOR AN AGREEMENT  
BETWEEN YORK COUNTY AND NORTH YORK BOROUGH, YORK COUNTY,  
PENNSYLVANIA FOR THE COLLECTION OF TAXES PURSUANT TO THE LOCAL  
TAX COLLECTION LAW, 72 P.S. SECTION 5511.4d  
NO. 2022-22**

**WHEREAS;**

NORTH YORK Borough (Borough) is a Borough organized and existing pursuant to the laws of the Commonwealth of Pennsylvania and is a taxing district as defined in the Local Tax Collection Law; and

YORK COUNTY (County) is a Third-Class County organized and existing pursuant to the laws of the Commonwealth of Pennsylvania; and

The Borough has been unable to fill the position of Tax Collector for its municipality; and

As authorized by Section 4d of the LTCL, 72 P.S. §5511.4d, the County and the Borough may enter into an Agreement for the collection of the taxes levied by the Borough by the County Treasurer under certain circumstances.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Borough of NORTH YORK, YORK COUNTY, Pennsylvania, as follows:

**SECTION 1:** The Council of the Borough of NORTH YORK hereby approves and authorizes and directs its President and Secretary to execute and deliver an Agreement for Collection of Municipal and County Taxes, a copy of which is attached as Exhibit "A" and incorporated by reference as if fully set forth (the "Agreement"). The specific terms, conditions and provisions of the Agreement are made a part of this Resolution.

**SECTION 2:** The terms and conditions of the Agreement are those as set forth in the attached Exhibit "A", incorporated as if fully set forth herein.

**SECTION 3:** The duration of the Agreement is for a set period of time as set forth in Section 4 of the Agreement (Exhibit "A") which shall expire December 31, 2023.

**SECTION 4:** The purpose and objectives of the agreement, including the powers and scope of authority delegated under the Agreement, are those as set forth in the attached Exhibit "A", incorporated as if fully set forth herein.

**SECTION 5:** The provisions of this Resolution are severable, and should any section, subsection, clause, sentence, or part be held or declared illegal, invalid, and unconstitutional by any court of competent jurisdiction, the decision shall not affect nor impair any of the remaining sections, subsections, clauses, sentences or parts. It is hereby declared to be the intent of the Borough Council that this Resolution would have been adopted if such illegal invalid or unconstitutional section, subsection, clause, or sentence or part had not been included.


**SECTION 6:** All Resolutions or parts thereof inconsistent with the terms of the Resolution are repealed to extent of such inconsistency.


**SECTION 7:** This Resolution shall become effective immediately.


