**A RESOLUTION OF THE BOROUGH OF NORTH YORK,
YORK COUNTY, PENNSYLVANIA, ESTABLISHING APPROVED FEES
FOR PROVIDING CERTAIN GOVERNMENTAL SERVICES AND FOR
RECOVERING CERTAIN ADMINISTRATIVE COSTS INCURRED
IN CONNECTION THEREWITH FOR 2023**

WHEREAS, the Borough of NORTH YORK is a political subdivision of the Commonwealth of Pennsylvania; and

WHEREAS, under the authority of the PA Borough Code, 8 Pa. C.S.A. §3301.1(c)(2), “Council shall adopt resolutions...” and “for any purpose, including, but not limited to, * * * statements of public policy of the council * * * [;]” and

WHEREAS, as a specific statement of public policy, NORTH YORK Borough wishes to adopt a fee schedule for certain governmental services and for the recovery of certain administrative costs incurred in connection therewith; and

WHEREAS, NORTH YORK Borough has established a schedule of fees for 2023 (Fee Schedule), attached hereto at Exhibit A, which is reasonable for the governmental services and administrative costs identified therein.


NOW, THEREFORE, be it resolved a follows:

2. This Resolution was duly adopted by a motion of NORTH YORK Borough Council.




