**RESOLUTION NO. 2023- 04**

**A RESOLUTION OF THE NORTH YORK BOROUGH COUNCIL  
PROVIDING FOR THE SALE OR DISPOSAL OF PERSONAL PROPERTY**

WHEREAS, North York Borough (hereafter, Borough) is a political subdivision of the Commonwealth of Pennsylvania, and it is governed in accordance with the Borough Code, which specifically provides that the Borough shall be governed by Borough Council (hereafter, Council), 53 P.S. §46006; and


WHEREAS, under the Borough Code, no personal property of the Borough shall be sold or disposed of without the approval of Council, 53 P.S. §46201.2; and

WHEREAS, the Borough has adopted a Resolution defining the terms and applicability of parameters surrounding the disposition of such property (Res. No. 2023- 01);


NOW, THEREFORE, be it resolved by Council:

1. Borough Manager was instructed and authorized to place for public bid on the Municibid website a total of 56 theater seats, arranged in 8 rows of 7 seats each, salvaged from the Council Chambers upon the reconditioning of the floors.
2. Borough Manager received a maximum bid of \$560 for this property on Municibid auction ending January 24, 2023, Listing #: 45293481.
3. Borough Manager was authorized and has completed the transaction. Council accepts the \$560 and directs the Treasurer to deposit these funds into the General Fund account.
4. This Resolution was duly adopted by a motion of Council this 14<sup>th</sup> day of February 2023.


